Notice

To: All Students (Main Campus)

Subject: Zero Tolerance Enforcement on Campus Decorum, Discipline & Unauthorized Activities

It has been observed with serious concern that certain students are violating institutional discipline, professional decorum, and safety protocols within the campus premises.

This is to notify all students that the institution is implementing a ZERO TOLERANCE POLICY with immediate effect.

Any deviation from the below directives will invite strict disciplinary and financial penalties without exception.

1. PROFESSIONAL DECORUM & CONDUCT (MANDATORY)

The campus is a professional academic zone, not a social or recreational space.

- Any form of inappropriate behavior, physical proximity, or Public Display of Affection (PDA) is strictly prohibited.
- Any act compromising the academic dignity of classrooms, corridors, or common areas will invite immediate action.

2. RESTRICTED AREA ACCESS – STRICTLY PROHIBITED

- Standing/sitting on balconies, railings, window ledges, eaves, or unsafe structures is strictly forbidden.
- Loitering outside classrooms, peeping through windows, or disturbing ongoing academic sessions will be treated as serious misconduct.

3. IDENTITY & MOVEMENT CONTROL

- Carrying a valid College ID Card is compulsory at all times.
- Students found in unauthorized areas without academic purpose will be removed from the premises and penalized.

4. DISCIPLINARY ACTION FRAMEWORK (NO EXCEPTION POLICY)

Any violation will be dealt with as per the following strict protocol:

- Immediate warning + monetary penalty (₹500 to ₹25000)
- Suspension from classes and academic activities
- Written undertaking from student is mandatory
- Written disciplinary notice
- Mandatory parent/guardian appearance on campus (no exception)
- Possible restriction from internal assessments/examinations

5. CCTV & EVIDENCE CLAUSE

- The entire campus is under CCTV surveillance.
- CCTV footage and official reports shall be treated as final evidence.
- No contrary explanation will be entertained.

6. NO EXCUSE / FINAL AUTHORITY CLAUSE

- Ignorance of rules will not be accepted under any circumstances.
- Decisions of the Proctorial Board and Principal shall be final and binding.

7. ACADEMIC PENALTY (CRITICAL)


Repeated violations may result in:
